### PROPOSED BUDGET FOR CY 2021

CY 2020 has been an atypical year due to the Coronavirus pandemic. For the purposes of budgeting it is assumed that CY 2021 will return to normal. The Association budget will be based on the following assumptions:

- 1. Activities will approximate the pre-pandemic period.
- 2. Four quarterly meetings
- 3. Expenses estimated on 4 quarters preceding pandemic
- 4. A 10% adder for (anticipated) higher restaurant expenses

Our pre-pandemic quarterly expenses averaged about \$1,700. Applying the 10% escalator brings quarterly expenses to \$1,870, resulting in an annual budget of \$7,480 which we round up to \$7,500. Naturally, the assumptions underlying this calculation may be off the mark in which case interim adjustments may be necessary.

Proposed GARA annual budget for CY 2021: \$7,500.

We expect to be able to maintain the annual dues at \$10 and will aim to keep the average luncheon ticket at \$30 - \$35. Naturally if restaurant costs increase as expected we may have to adjust this upwards for some venues.
